At its February 16th stated meeting, the Session, among other actions:

Approved the pastor attending CREDO Conference April 18-22, and moving the April Session meeting to April 27.

Approved the Spirit Moving Committee recommendation to accept the proposal from Design by Vie. They are to handle content creation and maintenance of website, social media channels, weekly email and monthly newsletter. The initial contract would be for 3 hours weekly at \$20/hour.

Approved the following requests from the Mission and Congregational Care Committee Solicit children's socks and underwear donations from the congregation for the Clothes Closet

- The special offerings for the year 2021: Thank Offering, Birthday Offering, 5 Cents a Meal, Pentecost Offering, Peace and Global Witness Offering, One Great Hour of Sharing, Joy Offering
- Spend \$247.00 from collected 5 Cents a Meal offerings to restock the Blessing Box
- Post an open letter to the congregation and the community to consider donating all or part of their stimulus checks to a Mission and Congregational Care benevolence fund.
- Hold a springtime yard sale and plant sale in the parking lot.

Approved the following recommendations from the Covenant Review Team

- Hire Melanie Rose to handle financial duties and assist treasurers part-time for up to 5 hours weekly at \$15.00/hour
- Change Chelsea Holt's title to Interim Music Director

Accepted a motion that the Session ask for volunteers to staff the church office Monday, Wednesday, and Friday, 9-12.



A letter from Pastor Rebekah



Friends,

The world is changing again. This time a year ago we were all under lock down, fearful of what the future would look like. In the past year we have lost loved ones, lost precious time, and learned how to cope. It seems like this past year has been a perpetual Good Friday – living in the reality of death. And yet, we have the promise of Easter. We have the promise of resurrection. As the flowers bloom, the birds sing, and the bunnies hop, we are reminded of new life, of hope. I, like so many of you, have received my vaccination. In fact, I received my second shot on Good Friday. (If you have not received your vaccination yet, I pray that you soon will.)

This truly is a new time. And yet, even on Easter we remember the pain of Good Friday. We remember the pain of death. We remember what has been lost. So, as we enter this time of new beginnings, this time of resurrection, I ask you to reflect on the question: what now?

What do we do now, as people of faith? What happens now that we have entered this new time? What does it mean now that we are safer? What now? We cannot go back, we can only go forward, so what will we do with this gift of newness? How will we embrace this new time? What now?

I pray God's blessings upon you all as you discover what this newness means for you and for OPC. I pray that when we gather, we will be safe. I pray that we do not forget our time of Good Friday, even as we rejoice in the promise of Easter.

OPC from 1926-1970

- 1926 A Sunday School Building was added to the rear of the church.
- 1935 The Men of the Church were organized.
- 1939-1942 Rev. William B. Ward served the church in an energetic and successful way until 1942 when he went to the Davis Memorial Church in Elkins, West Virginia. The membership grew to 156.
- 1941, July Mission Sunday School was started with John Moore as superintendent.
- 1942, February New pews were installed, many of them given as memorials to the following: Octavia Taliaferro, W. C. Boxley, Evelyn Johnson Williams, Jeannie B. Stribling and Charles Stribling.



1943, June - Rev. Albert G.

Edwards became pastor after
having preached at OPC for the
previous year while a student at
Union Theological Seminary. In
May 1945, Mr. Edwards was given
leave of absence to enter the
Army. In his absence, OPC was
supplied by three Seminary
students, Paul Warren, Charles

McCain and Edwin Packard.

- 1945 Membership was 169, the church was entirely debt free, Sunday School enrollment 90.
- 1952 The new Christian Building (Education Building?) was built and dedicated.
- 1957, September 1 Dedication of air conditioning and a set of communion vessels in memory of Mrs. Anna Ward Sherman.
- 1962, June 17 Two hymn boards, in memory of William Leland Lord (1888-1960) were dedicated.
- 1968, Oct. 15 Minutes of Congregational meeting: Presided by Richard E. Hildebrandt, Atwell W. Somervillle, Clerk of Session and J. Goodwin Moore Chairman of the planning council who stated: Architects were employed, schematic drawings were authorized for a

- sanctuary to seat approximately 400 people at a cost of \$200,000. Motion to build approved and motions to build and begin a finance campaign were approved: "Yes" 55, "No" 11.
- 1968, Dec. 31 344 members on roll, average attendance 160, number in armed services 10, church school enrollment 120 with 23 leaders. Minister's salary + manse \$9750. Total indebtedness: \$34,000. Total value of church property: \$209,000
- 1969 March Deacon Lorris Clements presented proposal relating to the widening of Main St. church property on corner of Main and Caroline —also approved reception of offering for weekday religious education in the schools of Orange County.
- 1969 April Funds collected for 4-wheel drive vehicle to be used in the Congo for the Rev. Day Carper.
- 1969, July Session recommended 12-month agreement use of part of Sunday School building for day care by Wee Care Private School Inc. 1970, May 12 - Records indicate second preschool, Little Folks Center, opening in old Library building.
- 1969, Sept 29 Approved aid to help in the Nelson Co. catastrophe challenge in the wake of Hurricane Camille.
- 1970 Total Budget: \$41,486, Benevolences \$11,150 (general assembly, senate and presbytery), current expenses: \$28,436 (pastor total reimbursement \$11,500 plus manse interest \$1900) Bible teacher Orange Co \$450. Note: building fund receipts \$27,000 not included in budget Total indebtedness: \$26,510 (manse).
- 1970, March 10 Youth Club program begins for youth grades 4 8 to include bible study, music, recreation, and fellowship (dinner).
- 1970, April 7 Congregational meeting approved the Rittenhouse low bid of \$213,177 for the new church and committed to spend up to \$246,000. Trustees commit to borrow amount not to exceed \$260,000 at interest of no more that 8% over 15 years. Trustees were authorized to convey strip of land on South side of Main St. to Town of Orange for purpose of widening street with town agreeing to construct new curb, gutter, sidewalk and retaining wall to and alter the front of the old sanctuary.
- 1970, June 9 \$120 for support to missionary C. Betts Huntley for support of Korean children, \$15 for dental work needed for local person.
